Finance Committee Meeting – December 11th, 2018

CAO John Pinsent presented the report of the Finance Committee:

- Revenues from the province (Tax Warrant and Unconditional Grant) have increased from 2018;
- AMANB conference sponsorship in June 2018 It was supported that the AMANB conference be sponsored by the ToW to the amount of \$5,000;
- The other sponsorships, although there was general agreement, would be formally approved in January;
- The unfunded liability will not be funded as in previous years but would be managed through management decisions, starting in 2019. The CAO will provide further options in 2019.
- Revenue at the AMC has not met expectations in 2018. More realistic expectations are included in Budget 2019;
- Animal Control would be managed differently in 2019 with agreements to be put in place with local animal shelters;
- Waste Management budget has been increased, recognizing that some fees have increased and there will be a second "clean-up" scheduled in 2019;
- From presentation and management perspective, Recreation will include Parks and Recreation and will include the maintenance of outdoor grounds, including playgrounds. Tourism will include a cultural aspect and manage sponsorships in the ToW;
- The water discount is to be eliminated and in FY 2019 only, those funds will be allocated to the acquisition of software and hardware to facilitate on line billing and collection;
- Workers Compensation has increased which has increased employer costs;
- Change to the Fire budget is a result of allocating funds to the Operating budget versus the Capital budget. Overall budget for the running the fire department has not increased materially;

- The budget for planning will remain as it has in the past and will be used for potential joint projects with the CoC or the BIA;
- Capital Budget was agreed to with the one exception, that we forgo the additional police cruiser in 2019 and use those funds for additional paving; and
- Budget for paving and sidewalks was reviewed with the awareness that future work may be required on Helen Street, to be determined in 2019.

It was recommended that:

- The water charges be increased by 10%;
- The early payment discount for Water and Sewer charges be eliminated; and

No tax increase in 2019

Planning Advisory Committee – December 17th, 2018

2019 General Utility and Capital Fund Budgets

The General and Utility Budget was presented by CAO Pinsent and Councillor Sutherland.

General Fund:

Councillor Sutherland noted that there will not be a tax increase for 2019.

Utility Fund:

In reviewing the Utility budget Councillor Sutherland noted that there will be a 10% increase in the Water rates for 2019 as well as the discontinuation of the early payment 5% discount.

Long-term debt for Rotary and Capital Project:

CAO Pinsent stated that revenues will be collected to offset the Rotary loan over the next three years.

MOTION: The sum of \$9,842,032 be the total operating budget of the Municipality, that the sum of \$7,238,514 be the Warrant of the Municipality for the ensuing year, and that the tax rates for the Local Government be \$1.43 (Inside), \$1.38 (Outside) and \$1.38 (Industrial Park). The Council orders and directs the levying by the Minister of Environment and Local Government of said amount of real property liable to taxation under the Assessment Act within the Local Government of Woodstock. Councillor Sutherland, Councillor Leonard.

MOTION: That pursuant to paragraph 117(4) of the Local Governance Act, the total budget for the Water / Sewer Utility for the ensuing year would consist of total revenues of \$1,444,000, and total expenditures of \$1,444,000. Councillor Sutherland, Councillor Bradbury.
