

ARE THESE DESIGNATED STREETS ACCESSIBLE TO ALL ATVS?

No, only ATV/Quads registered with a provincial ATV Club that is a member of the QuadNB, or a member of any ATV club from a province in Canada having a reciprocating agreement with the QuadNB. The registration sticker must be permanently displayed and clearly visible.

ATV/Quads must also be insured. Drivers must be able to immediately provide registration and insurance documents.

WHAT IS THE MINIMUM LEGAL AGE TO DRIVE AN ATV ON TOWN OF WOODSTOCK STREETS?

As per By-Law No. 2022-01, you must have a valid Driver's License and be a minimum of 16 years of age to drive an ATV/Quad on Town of Woodstock streets.

CAN A MOTOCROSS OR DIRT BIKE USE THE TOWN STREETS?

No, In the New Brunswick Off-Road Vehicle Act, dirt bikes and/or motocross are not included in the definition of an ATV or off-road vehicle. Dirt bikes are not allowed on any town street or non-motorized path.

AT WHAT SPEED ARE ATVS ALLOWED TO TRAVEL?

ATV/Quad drivers must respect *the speed limit of 40 km/hr*. Community members can expect ATV/Quad drivers to follow posted speed limits and drive single file in the same direction as traffic within the regular flow of traffic.



by law ebforcement, law enforcement has the power to issue fines ranging from \$100.00 to \$2,500.00. Officers can apply one or more infractions as identified in By-Law No. 2022-01, the Motor Vehicle Act, and the Off-Road Vehicle Act.

WHAT OTHER SAFETY RULES ARE ATV DRIVERS EXPECTED TO FOLLOW?

ATV drivers *must wear a proper safety helmet that complies with the Motor Vehicle Act,* use signal lights or hand signals for turning and stopping, abide by noise restrictions in applicable legislation, and ensure their ATV is outfitted with the necessary equipment as described in the Off-Road Vehicle Act

Frequently Asked Questions

ON WHICH STREETS IN WOODSTOCK ARE ATVS ALLOWED TO TRAVEL?

ATV/Quads can travel on. . .

- Houlton Street (Route 103) from civic no. 164 to Main Street (intersection of Route 103 & Route 165)
- *Main Street* from the intersection of Houlton Street (Route 103 & Route 165) to Connell Street (intersection of Route 550 & Route 165)
- Connell Street (Route 550) from 104 Connell Street to 1417 Connell Street
- Gallop Court to civic no. 123 and Gallop Street to civic no 104
- King Street to civic no. 220
