

BY-LAW NO T-230

A BY-LAW TO CONTROL TRAFFIC

THE TOWN OF WOODSTOCK, UNDER AUTHORITY VESTED IN IT BY THE MOTOR VEHICLE ACT, C.M-17, R.S.N.B. 1973, AND AMENDMENTS THERETO, HEREBY ENACT THE FOLLOWING:

INTERPRETATION

1. WHEN USED IN THIS BY-LAW, THE WORDS DEFINED IN SECTION 1 OF THE MOTOR VEHICLE ACT, BEING CHAPTER M-17 OF THE REVISED STATUTES OF NEW BRUNSWICK, 1973 AND AMENDMENTS THERETO, HAVE THE SAME MEANING AS IN THE SAID MOTOR VEHICLE ACT UNLESS OTHERWISE DEFINED IN THIS BY-LAW.

- (A) SCHOOL ZONE MEANS A PORTION OF A HIGHWAY IN THE VICINITY OF A SCHOOL BUILDING, THE LIMITS OF WHICH ARE MARKED BY SIGNS INDICATING THE PRESENCE OF A SCHOOL ZONE OR PEDESTRIANS.
- (B) TRAFFIC CONTROL DEVICE AND TRAFFIC CONTROL SIGNAL SHALL BE DEFINED AS THE SAME ARE DEFINED IN SECTION 1 OF THE SAID MOTOR VEHICLE ACT.

STOPPING, STANDING OR PARKING OF VEHICLES

2. EXCEPT WHERE PARKING IS PROHIBITED, VEHICLES MAY BE PARKED ON THE LEFT SIDE OF A ONE-WAY HIGHWAY PROVIDED THAT ANY VEHICLE SO PARKED SHALL BE PARKED WITH THE LEFT WHEELS OF SUCH VEHICLE PARALLEL TO AND WITHIN FIFTY CENTIMETRES OF THE LEFT-HAND CURB OR OUTER EDGE OF THE LEFT SHOULDER OF A ONE-WAY ROADWAY.

3. NO MOTOR VEHICLE SHALL BE PARKED OTHER THAN WHERE PARKING SPACES ARE DESIGNATED WHICH MAY BE BY PAINTED LINES OF DEMARCATION AND WHERE THERE ARE SUCH DESIGNATIONS EVERY MOTOR VEHICLE MUST BE PARKED WHOLLY BETWEEN OR WITHIN THE LINES OF DEMARCATION AND THERE SHALL BE NO PARKING WHERE ANY DESIGNATION OR DEMARCATION PROHIBITS SAME.

4. (1) BETWEEN THE 15TH DAY OF NOVEMBER IN EACH YEAR AND THE 15TH DAY OF APRIL NEXT FOLLOWING, BOTH DATES INCLUSIVE, NO PERSON SHALL PARK A MOTOR VEHICLE UNATTENDED ON ANY HIGHWAY BETWEEN THE HOURS OF MIDNIGHT AND 7:00 O=CLOCK IN THE MORNING NEXT FOLLOWING.

(2) IF ANY MOTOR VEHICLE IS SO PARKED AND IS INTERFERING, OR IS CONSIDERED BY A PEACE OFFICER OF THE TOWN TO BE LIKELY TO INTERFERE WITH SNOW PLOWING OR SNOW REMOVAL, ANY SUCH PEACE OFFICER MAY CAUSE SUCH MOTOR VEHICLE TO BE REMOVED TO A PLACE OF SAFETY AND THERE STORED, AND THE COST OF SUCH REMOVAL AND STORAGE SHALL BE PAID BY THE OWNER OR PERSON IN CHARGE OF SUCH MOTOR VEHICLE.

(3) IT IS HEREBY DECLARED THAT THE PROVISIONS OF THIS SECTION ARE ENACTED FOR THE PURPOSE OF SNOW REMOVAL.

5. (1) THE TOWN COUNCIL, SUBJECT TO APPROVAL RECEIVED FROM THE MINISTER OF TRANSPORTATION, MAY FROM TIME TO TIME, APPOINT AREAS WHERE ANGLE PARKING MAY BE PERMITTED OR DIRECTED.

(2) FOR THE PURPOSE OF THIS SUBSECTION (1), AREAS FOR ANGLE PARKING DESIGNATED THEREUNDER MAY BE INDICATED BY LINES PLAINLY PAINTED ON THE SURFACE OF THE HIGHWAY.

6. NO MOTOR VEHICLES SHALL PARK ON EITHER SIDE OF QUEEN STREET BETWEEN MAIN STREET AND RICHMOND STREET, UNLESS THE FRONT OF ANY VEHICLE IS POINTED IN AN EASTERLY DIRECTION ONLY.

7. (1) NO COMMERCIAL VEHICLE OF 4,500 KG OR GREATER SHALL BE PARKED WHETHER ATTENDED OR UNATTENDED:

(A) ON MAIN STREET BETWEEN ELM STREET AND BROADWAY;

(B) ON KING STREET;

(C) ON QUEEN STREET.

(2) THE PROHIBITION NOTED HEREIN SHALL NOT PREVENT THE PARKING OF COMMERCIAL VEHICLES OF 4,500 KG OR GREATER FOR MAKING DELIVERIES OF LESS THAN 30 MINUTES IN DURATION WHERE LOADING ZONES ARE NOT

PROVIDED.

STREETS

8. NO PERSON SHALL:

(A) ERECT, PLACE, PUT OR MAINTAIN ANY BUILDING, STRUCTURE, GASOLINE PUMP, LUMBER, LOGS, STONES, REFUSE, SNOW OR OTHER ENCUMBRANCE OR OBSTRUCTION OVER OR UPON ANY STREET,

(B) ALTER ANY STREET, OR FILL UP OR OBSTRUCTS ANY DITCH, WATER COURSE OR DRAIN CONSTRUCTED FOR THE PURPOSE OF CARRYING OFF WATER FROM A STREET,

(C) IN ANY MANNER, EXCEPT IN THE REASONABLE USE OF A STREET, BREAK THE SHOULDER OF OR OTHERWISE DAMAGE A STREET,

(D) DEFACE, DESTROY OR REMOVE ANY TRAFFIC CONTROL DEVICE,

(E) DAMAGE OR DEFACE ANY STREET, BRIDGE OR CULVERT,

(F) WILLFULLY HINDER OR INTERRUPT ANY OFFICER, ENGINEER OR AGENT ACTING UNDER THE AUTHORITY OF THE TOWN IN THE LAWFUL EXERCISE OF THEIR DUTIES,

(G) ALLOW OR PERMIT WATER, WATER PRODUCTS, PETROLEUM PRODUCTS OR OTHER LIQUIDS TO FLOW ONTO, OR UPON A STREET,

(H) PLACE OR CAUSE TO BE PLACED OR DEPOSITED SNOW, ICE OR A COMBINATION THEREOF ON A STREET OR SIDEWALK WHILE IN THE PROCESS OF SNOW PLOWING.

RESERVED PARKING AREAS

9. (1) THE FOLLOWING PORTIONS OF HIGHWAY ARE DESIGNATED AS RESERVED PARKING AREAS AND SHALL BE MARKED AS DESIGNATED BY APPROPRIATE SIGNS OR MARKINGS SHOWING THE LIMITS THEREOF:

(A) 15 MINUTE PARKING, ON THE EAST SIDE OF MAIN STREET BETWEEN REGENT STREET AND CHURCH STREET BEING IN FRONT OF THE FEDERAL BUILDING AND ST. LUKES ANGLICAN CHURCH.

(B) 15 MINUTE PARKING, ON THE WEST SIDE OF MAIN STREET BETWEEN CHAPEL STREET AND MAPLE STREET BEING IN FRONT OF THE L.P. FISHER LIBRARY, JAMES YERXA APARTMENTS AND T D CANADA TRUST.

(C) 120 MINUTE (2 HOUR) PARKING:

- ON THE NORTH SIDE OF KING STREET.
- ON THE EAST SIDE OF CARLETON STREET.
- ON THE SOUTH SIDE OF HARVEY STREET.
- ON THE NORTH AND SOUTH SIDES OF QUEEN STREET.

- ON THE EAST SIDE OF RICHMOND STREET.
- ON THE SOUTH SIDE OF CONNELL STREET BETWEEN MAIN STREET AND THE ELKS LODGE PROPERTY.
- ON THE WEST SIDE OF MAIN STREET FROM CHAPEL STREET TO WATER STREET.
- ON THE EAST SIDE OF MAIN STREET FROM REGENT STREET TO KING STREET.
- ON THE SOUTH SIDE OF EMERALD FROM MAIN STREET TO THE WEST A DISTANCE OF 70 METERS.

(D) HANDICAPPED PARKING ONLY,

- ONE SPACE ON MAIN STREET IN FRONT OF THE UNITED BAPTIST CHURCH

- ONE SPACE ON GREEN STREET IN FRONT OF THE ENTRANCE TO ST. JAMES UNITED CHURCH.

(2) NO PERSON SHALL STOP, STAND OR PARK A VEHICLE IN A HANDICAPPED PARKING AREA UNLESS HE IS THE HOLDER OF A PERMIT FOR SUCH PURPOSE ISSUED BY THE APPROPRIATE PROVINCIAL

AUTHORITY.

(3) ANY VEHICLE PARKED IN AN AREA DESIGNATED IN SECTION 9(1)(A)(B)(C) AND (D) MAY HAVE AN ERASABLE CHALK MARK PLACED ON THE TREAD FACE OF ANY TIRE BY A PEACE OFFICER IN ORDER TO DETERMINE THE TIME SAID VEHICLE HAS BEEN PARKED AND NEITHER THE PEACE OFFICER NOR THE TOWN SHALL INCUR ANY LIABILITY FOR SO DOING.

ONE-WAY HIGHWAYS

10. (1) QUEEN STREET SHALL BE A ONE-WAY STREET BETWEEN MAIN STREET AND RICHMOND STREET.

(2) NO VEHICLES SHALL ENTER THIS SECTION OF QUEEN STREET FROM THE EASTERN ENTRANCE AND VEHICLES SHALL NOT PROCEED ALONG SUCH STREET IN A WESTERLY DIRECTION.

11. (1) MAPLE STREET SHALL BE A ONE-WAY STREET BETWEEN MAIN STREET AND GREEN STREET.

(2) ON MAPLE STREET NO VEHICLES SHALL ENTER MAPLE STREET FROM GREEN STREET ENTRANCE AND SHALL NOT PROCEED ALONG MAPLE STREET IN AN EASTERLY DIRECTION.

(3) ON HARVEY STREET NO VEHICLES SHALL ENTER HARVEY STREET FROM EITHER CARLETON STREET OR QUEEN STREET OR WELLINGTON STREET ENTRANCE AND SHALL NOT PROCEED ALONG HARVEY STREET IN A WESTERLY DIRECTION.

SPEED OF VEHICLES IN PUBLIC PARKS

12. (1) NO VEHICLE SHALL PROCEED AT A SPEED IN EXCESS OF 30 KM PER HOUR, AS POSTED, ON THE CONNELL PARK ROAD, WITHIN THE BOUNDARIES OF CONNELL PARK, BEING A PUBLIC PARK.

(2) NO VEHICLE SHALL PROCEED AT A SPEED IN EXCESS OF 30 KM PER HOUR, AS POSTED, WITHIN THE BOUNDARIES OF CENTENNIAL PARK, BEING A PUBLIC PARK.

SPEED OF VEHICLES IN SCHOOL ZONES

13. NO VEHICLE SHALL PROCEED AT A SPEED IN EXCESS OF 30KM PER HOUR, AS POSTED, WITHIN A SCHOOL ZONE.

14. ANY SCHOOL ZONE WHICH IS ALONG A PROVINCIAL HIGHWAY SHALL NOT BE SUBJECT TO THE PROVISION OF SECTION 13. HEREIN.

THROUGH HIGHWAYS

15. (1) THE FOLLOWING STREETS AND PORTIONS OF STREETS ARE DESIGNATED THROUGH HIGHWAYS AND, EXCEPT WHERE TRAFFIC IS CONTROLLED BY TRAFFIC CONTROL SIGNALS, OR WHERE OTHER PROVISION IS MADE HEREIN, STOP SIGNS SHALL BE ERECTED AT ALL ENTRANCES THEREOF:

(A) MAIN STREET;

(B) CONNELL STREET;

(C) HOULTON STREET;

(D) ROUTE 2 BEING THAT PORTION WITHIN THE BOUNDARIES OF THE TOWN OF WOODSTOCK.

(2) STOP SIGNS SHALL BE ERECTED AT ALL PLACES AS SET OUT IN SCHEDULE "A" HERETO FORMING A PART HEREOF.

OPERATION OF BICYCLES

16. NO PERSON SHALL OPERATE A BICYCLE ON ANY SIDEWALK EXCEPT FOR THE PURPOSE OF CROSSING SAME.

LEFT HAND TURNS

17. NO PERSON DRIVING A VEHICLE IN AN EASTERLY DIRECTION ON CONNELL STREET SHALL TURN SUCH VEHICLE IN A NORTHERLY DIRECTION AT THE INTERSECTION OF CONNELL STREET AND MAIN STREET.

COMMERCIAL TRAFFIC

18. (1) THE DRIVER OF ANY COMMERCIAL VEHICLE HAVING A GROSS WEIGHT OF 4,500 KG OR MORE SHALL NOT DRIVE ON THE FOLLOWING STREETS, NAMELY:

(2) FOR THE PURPOSE OF THIS SECTION, NOTICE OF PROHIBITION SHALL BE GIVEN BY SIGNS POSTED ON OR NEAR THE STREETS LISTED IN SECTION (1), (A), (B) AND (C).

(3) THE PROHIBITION NOTED HEREIN SHALL NOT PREVENT A DRIVER ACCESS TO THE STREETS FOR THE BONA FIDE PURPOSES OF DELIVERING OR TAKING DELIVERY OF A LOAD THEREFROM.

GENERAL

19. ANY PERSON IN CHARGE OF A VEHICLE WHICH IS INTERFERING WITH THE WORK OF THE FIRE DEPARTMENT SHALL MOVE SUCH VEHICLE, IF DIRECTED TO DO SO BY A PEACE OFFICER OR AN OFFICER OF THE FIRE DEPARTMENT.

20. PURSUANT TO S.116 (1), (2) AND (3) OF THE MOTOR VEHICLE ACT, THE CHIEF ADMINISTRATIVE OFFICER IS HEREBY AUTHORIZED TO PLACE TRAFFIC CONTROL DEVICES FOR AND ON BEHALF OF THE TOWN OF WOODSTOCK.

21. NO PERSON SHALL DRIVE A MOTOR VEHICLE THROUGH A STREET WHICH IS ROPED OFF, BARRICADED OR CLOSED AS INDICATED BY WORDS IN WRITING OR OTHERWISE DESIGNATED.

22. NO PERSON SHALL DRIVE A MOTOR VEHICLE IN SUCH A MANNER AS TO SPLASH OR THROW WATER, MUD, SLUSH OR SNOW ON ANY PEDESTRIAN.

23. NO PERSON SHALL DRIVE A HORSE OR VEHICLE UPON A FOOTPATH OR SIDEWALK EXCEPT FOR THE PURPOSE OF DIRECTLY CROSSING SUCH FOOTPATH OR SIDEWALK.

24. NO PERSON SHALL DRIVE A HORSE UNATTENDED ON ANY HIGHWAY, OR IN ANY PUBLIC PARKS OR PUBLIC PARKING LOTS, UNLESS THE HORSE OR THE VEHICLE TO WHICH IT IS HARNESSSED IS FIRMLY FASTENED TO A POST OR WEIGHT.

25. EXCEPT IN AN INTERSECTION NO DRIVER OF A VEHICLE SHALL MAKE OR ATTEMPT TO MAKE A TURN IN ONE FORWARD MOTION, COMMONLY CALLED A "U" TURN, ON ANY STREET.

OFFENCE

26. IT IS AN OFFENCE FOR ANY PERSON TO DO ANY ACT FORBIDDEN OR FAIL TO PERFORM ANY ACT REQUIRED BY THE BY-LAW OR OTHERWISE TO CONTRAVENE THE PROVISIONS OF THIS BY-LAW.

27. THE OWNER OF A MOTOR VEHICLE SHALL BE GUILTY OF ANY VIOLATION OF THIS BY-LAW COMMITTED BY ANY PERSON OPERATING OR IN CHARGE OF SUCH MOTOR VEHICLE PURSUANT TO THE PROVISIONS OF SECTION 270 AND 270.1 OF THE MOTOR VEHICLE ACT R.S.N.B. C.M. -17 AND THE SAID PROVISIONS APPLY MUTATIS MUTANDIS TO THE WITHIN BY-LAW AS IF SET OUT HEREIN.

PENALTIES

28. (1) EXCEPT AS PROVIDED ELSEWHERE IN THIS BY-LAW, PENALTIES SHALL BE:

(A) RESERVED PARKING AREAS:
FIFTEEN (\$15.00) DOLLARS.

(B) ALL OTHER VIOLATIONS:
A MINIMUM OF TEN (\$10.00) DOLLARS AND A MAXIMUM OF FIFTY (\$50.00) DOLLARS.

(2) VOLUNTARY PAYMENTS OF PENALTIES AS NOTED HEREIN SHALL BE PAYABLE WITHIN FOURTEEN (14) DAYS AT THE WOODSTOCK TOWN OFFICE OTHERWISE, THESE PENALTIES SHALL BE RECOVERABLE UNDER THE PROVINCIAL OFFENCES PROCEDURE ACT CHAPTER P-22.1 S.N.B.
